Eligibility to Purchase

In order to place an order through this website, customers must provide personal information including, but not limited to, their real name, telephone number, and email address, as well as any other required information. Customers must also provide valid and accurate payment details and confirm that the billing information belongs to them.

By placing an order for NNormal products, customers expressly consent to NNormal conducting credit checks and, where necessary, transmitting customer information to or obtaining such information from third parties, including for credit card authorization and transaction approval.

Personal Information

Customers' personal information will be registered in databases managed by NNormal and used for processing and delivering orders. Customers have the right to access, correct, or delete their personal information in accordance with the procedures set forth in the Privacy Policy.

Product Availability

Products displayed on this website represent only a selected portion of the NNormal catalog and are specifically selected for the online shop. Product availability may change, and items may be out of stock. NNormal is not responsible for out-of-stock items. Product collections may change seasonally.

How to Purchase

All prices are displayed in Japanese Yen and include applicable taxes. The price displayed at the time of order confirmation shall apply. NNormal reserves the right to change prices at any time prior to order completion.

Payment Methods and Security

Orders are accepted 24 hours a day. Payment methods include credit card, Apple Pay, or cash on delivery. Customers must confirm authorization from the card issuer. Secure payment systems using SSL encryption are employed.

Delivery

Products are shipped Monday through Friday excluding public holidays. Delivery is limited to residential or business addresses within Japan.

Order Cancellation

Orders may be canceled prior to shipment for a full refund. After shipment, returns may be made in accordance with the return policy.

Returns

Returns are accepted within 30 days of receipt, excluding socks and flasks. Returned items must be unused and in original condition.
